Cookie policy

Cookies are small strings that are saved locally within the user's browser to exchange information with the website.

These strings are used for various functionalities, including analyzing sessions, storing information to improve the browsing experience or the functionality of the site. The cookies that are saved during navigation can come from the site itself (proprietary) or be installed by tools or objects contained within the website (third parties).

The general provision of the Privacy Authority (Official Gazette no. 126 of 3 June 2014) defines two types of cookies:

- Technical cookies Used for the sole purpose of allowing the transmission of communication, to complete a service requested by the user or to carry out statistical research.
- Profiling cookies Used to record a user's behavior and preferences in order to send advertising messages in line with their profile.

This website does not use any profiling cookies.

Types of cookies

These are the cookies that are used by NOME within the site

Category	Typology	Purpose
Technical	Owners	These cookies allow the website to function properly and the user's browsing preferences, including language or access to restricted areas.

Statistics	Third-party	Google Analytics is a free tool from Google that allows you to collect information on the use and browsing experience of users on the website.
		We use this information to optimize the content and elements of the website without collecting any personal information from users whose IP address data is recorded anonymously.

Disabling cookies

Disable Google Analytics cookies

Browsers are usually enabled to accept cookies from websites. However, you can control and disable cookies through the settings of each browser. This restriction may impair certain features of this website.

Below are the procedures for disabling cookies from the most common browsers

Google Chrome

- Open Chrome on your computer.
- Click More then Settings in the top right.
- At the bottom, click Advanced.
- Click Content Settings in the "Privacy & Security" section.
- Click on Cookies.
- From here you can:
 - Turn on cookies: Turn on the option next to "Blocked."
 - o Turn off cookies: Turn off the Allow sites to save and read cookie data option.

Mozilla Firefox

- Click the Menu button and select Preferences.
- Select the Privacy & Security panel and navigate to the History section.
- Under History settings: Select Use custom settings.
- To enable cookies, mark Accept cookies from websites; to deactivate them, remove the flag from the entry.
- Choose how long cookies can be stored:
- Store them until:
 - When they expire: Cookies will be removed when they reach their expiration date (date set by the site sending the cookies).

- When Firefox is closed: Cookies stored on your computer will be removed when Firefox is closed.
- Close the about:preferences page. Any changes you make will be saved automatically.

Internet Explorer

- In Internet Explorer, select the Tools button, and then select Internet Options.
- Select the Privacy tab, and then under Settings, move the slider up to block all cookies or down to allow all cookies, and then select OK.
