To this end, this policy describes the methods of management of the site with reference to the processing of the personal data of users who consult it.

Data and purposes of processing

Impala S.r.l. informs that the data provided by the user are used exclusively for purposes related to the execution of the service or performance requested.

No data is communicated or disseminated except to perform the service or performance requested.

Purpose and legal basis of the processing

The data subject to processing are browsing data and data provided voluntarily by the user.

Browsing data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified data subjects, but which by its very nature, could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the URI (Uniform Resource Identifier) addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given to the server and other parameters relating to the operating system and the IT environment of the user.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.

The processing for this purpose is based on the legitimate interest of the Data Controller in the correct technical functioning of the website (Art. 6.1 letter f) GDPR).

Data provided voluntarily by the user





Impala S.r.l. will use the data collected for activities strictly connected and instrumental to the management NG of contact requests, if the user contacts our company by writing an e-mail to the addresses indicated or by filling out the form in the appropriate section of the site. The User's data collected by the Data Controller for this purpose include all additional User data that may be voluntarily communicated by e-mail.

Processing for this purpose is based on the execution of pre-contractual measures adopted at the request of the data subject (Art. 6.1 letter b) GDPR).

Processing methods

The data processing will be carried out pursuant to Art. 4 no. 2) of the GDPR, by means of the following operations: collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data. It can be carried out both with the use of paper supports and with the aid of electronic computer and telematic tools, according to methods and with tools suitable for guaranteeing the security and confidentiality of the data themselves. In particular, all technical and organizational measures will be taken to ensure an adequate level of security with respect to the risk.

The processing is carried out through automated systems for a period strictly necessary to achieve the purposes for which they were collected and, in any case, in accordance with the legislative provisions in force.

Your data, starting from their receipt/update, will be stored for a period appropriate to the purposes of the processing indicated above.

Communication and dissemination of data

Personal data are processed by employees and/or collaborators of the Data Controller and will not be disseminated or communicated to third parties, except in the cases provided for by the legislation and in any case according to the methods permitted by the same.

Personal data may be processed by employees of Impala S.r.l., who operate as people authorized to process data, and by service providers (e.g. marketing and communication agencies, IT companies) on the basis of specific contractual agreements.

Rights of the data subject

In relation to the aforementioned data, the rights of access, rectification and cancellation of data may be exercised at any time; the rights to limit or object to processing and the right to data portability, i.e. to receive the data in a structured format of common use and readable by an automatic device and to be able to transmit them to another Data Controller without hindrance. More specifically, reference is made in full to the provisions of art. 15, 16, 17, 18, 20 and 21 of the GDPR. In the event of a violation, the data subject has the right to lodge a complaint with the competent supervisory authority (Art. 77 GDPR).
